(I) ANNUAL REGISTRATION FEES

By Companies, *Sociétés Commerciales*, Limited Partnerships, Limited Liability Partnerships and Foundations for 2022

The public is hereby informed that, in accordance with the Companies Act 2001, the Limited Partnerships Act 2011, the Limited Liability Partnerships Act 2016 and the Foundations Act 2012, annual registration fees should be paid during the period **03 to 20 January 2022**.

Payment of fees in respect of the following may be effected as from the first working day, that is, **03 to 20 January 2022** at the office or online.

Payment of Registration Fees by a Small Private Company

Small private companies are reminded that the payment of 2022 annual fees depend on their turnover i.e. -

A fee of Rs 500 is payable in case turnover does not exceed Rs 10 Million.

*** Note (1): The amount to be claimed as Registration fee will be based on the turnover recorded at this Office.**

In case the financial summary has not been filed or not due yet, the fees must be accompanied by a Declaration made by the Director(s) that the turnover of the Company has not exceeded 10 million rupees during the last preceding accounting period. Please ensure that fees have been adjusted prior to making the payment.

A specimen of the Declaration Form may be downloaded from our Website or collected at the Counter on the ground floor of the office.

(II) TRADE FEE

Following amendment to **The Local Government Act**, payment of Trade Fees for the financial year 2021/2022 is now effected at the office of the **Corporate and Business Registration Department (CBRD)** as follows:-

- a) In a single instalment **on or before 20 January 2022**; or
- b) Where the fees due exceed the sum of 5,000 rupees, in 2 equal instalments, **the first instalment being paid on or before 20 January 2022** and the second instalment being paid on or before 30 June 2022.

Note (2): In accordance with regulation 3 (1) of **The Local Government (Fees) Regulations 2019**, those businesses whose classified trade and the fee leviable are not more than MUR 5,000, are exempted from payment of trade fee.

Note also that **trade fee should be paid in respect of classified trade regulated under The Excise Act and the Gambling Regulatory Authority Act.**

Exemption from payment for businesses registered on or after 5 August 2021

(Amendment brought to The Local Government Act, through the Finance (Miscellaneous Provisions) Act 2021)

Businesses registered on or after 5 August 2021 are exempted from the payment of Trade Fees for two financial years; the first financial year being the current one ending on 30 June 2022 and the second financial year will end on 30 June 2023.

Trade Fees in respect of these businesses will therefore become payable as from 1 July 2023.

(III) Other Fees

Agent in Land and/or Building or Estate Agency

Land Promoter and Property Developer

With effect as from 1st November 2020, at present and until further notice, the amounts as prescribed in “The Local Government (fees) Regulations 2019” are still being collected by the office of the Registrar of Companies on behalf of **The Real Estate Agent Authority**.

1. Procedures for payment of Registration fees

Pursuant to paragraphs 5(1) & (2) of the Regulations dated 9 January 2016 (GN 3 of 2016 refers)

The following entities **must**, according to the above regulations, use the online service:

1. A person providing a service by making a filing or payment required under the Act or a relevant Act.
2. Audit Firm.
3. Company with turnover of 50 million rupees or more.
4. Company Service Provider
5. Law firm.
6. Management Company or company with a management licence issued under the Financial Services Act.
7. Registered Agent

2. Modes of Payment

Payment can be effected in the following manners:

a) CASH (payable only at CBRD)

Payment may be effected as follows:-

By calling at the Cash Office situated on ground floor at One Cathedral Square Building, Jules Koenig Street, Port Louis during the following official hours:

Weekdays: 8.30 a.m. to 4.30 p.m.

Saturdays: 8.30 a.m. to 4.00 p.m.

All the counters of CBRD will operate in a new alphabetical order system from 3 to 20 January 2022 as follows:

A to H on Mondays and Thursdays

I to Q on Tuesdays and Fridays; and

R to Z on Wednesdays and Saturdays

b) PAYMENT BY CHEQUES

Any cheque either **deposited or posted** should reach this office on or before **20 January 2022 at latest by 4.00 p.m.** otherwise a different fee will be applicable.

The cheque should:

- *be payable to the Government of Mauritius*
- *be crossed*
- *clearly indicate on verso, the file number and name of the company and the name, address and phone number of a contact person.*

c) ONLINE PAYMENT:

In order to effect online payment, the persons listed at **1** above (if not already registered) should be registered with the Mauritius Network Services (MNS) at <https://portalmns.mu/cbris/>.

(i) Procedures for paying Registration Fee online

Once registered, the following steps must be followed:

- ✓ Click on the **'Pay Yearly/Trade Fees'**
- ✓ Go to **'Dashboard'** and click on **'Search Pending Fees'**
- ✓ Click on **'Yearly Fees'**
- ✓ Once a list of **'Pending Yearly Fees'** appear, select the **company/ companies** for which payment has to be effected. The item(s) will instantly be added to cart. A cart summary is displayed on the right-hand side of the application.

- ✓ To effect payment, select the appropriate **'mode of payment'**, be it **'Deposit Account'** (MUR & USD), **'Electronic Payment'** (MUR only) or **'Credit Card'** (MUR only).

(ii) Procedures for paying Trade Fee (including Fees at III above) online

- ✓ Click on the **'Pay Yearly/Trade Fees'**
- ✓ Go to **'Dashboard'** and click on **'Search Pending Fees'**
- ✓ Click on **'Trade fees'** and select the appropriate BRN
- ✓ Select the Instalment to be paid for.
- ✓ On the left of screen, click on **'Check Amount Due'** and proceed to payment.

(iii) Procedures for paying Trade Fee (including Fees at III above) online (by an Individual)

- ✓ Step 1 – Register for a login and password:

- ✓ Step 3: Fill in the required information and effect payment using a credit card.

d) PAYMENT FROM DEPOSIT ACCOUNT

Note (3): Companies operating a Deposit A/C with CBRD should ensure that they replenish same in advance to enable payment of Registration Fees 2022 and/or Trade fee as from 3rd January 2022.

e) ELECTRONIC TRANSFER VIA LOCAL BANKS (FOR MUR ONLY)

f) BY DEBIT/CREDIT CARDS (applicable for payment at CBRD's Cash Office)

Note (4): If payment is effected by credit/debit card, a Service Charge of 1.725% is applicable for payment exceeding Rs 25 000.

Companies, Sociétés, Limited Partnerships, Limited Liability Partnerships and Foundations are reminded that it is their responsibility to ensure that payment of Registration Fee and/or Trade fee is effected not later than 20 January 2022.

After the due date, i.e. 20 January 2022, another fee is applicable.

The public is also informed that a list of Companies/ Sociétés Commerciales/ Limited Partnerships/ Limited Liability Partnerships and Foundations with the corresponding annual registration fees payable is available on our website companies.govmu.org for consultation.
