- 2. In these regulations –

"Principal regulations" means the Companies (Prescribed Forms) Regulations 2001.

- 3. The principal regulations are amended –
- 4. (a) by repealing the First Schedule and replacing it by First Schedule to the Regulations;
- 5. (b) by repealing the Fifth Schedule and replacing it by the Second Schedule to these regulations
- 4. These regulations shall be deemed to have come into operation on 1st October 2006.
