**Procedures for removal of a "Societe  
Commerciale"**

1. The Registrar of Companies will proceed with the removal of a "Societe Commerciale" after three years in any of the following circumstances:
  - a. When records show that the duration for the period fixed has expired and not been renewed or
  - b. When payment of fees under the Twelfth Schedule of the Companies Act has not been effected.
2. A notice containing the following particulars will be published in the Government Gazette
  - a. the name of the "Societe Commerciale" and its registered office,



- b. the ground of removal,
- c. the date by which an objection to the removal is to be delivered to the Registrar which should be not less than 28 days after the date of the notice
3. An objection under 2(c) to the removal may be made on the grounds that:
- the "Societe Commerciale" is still carrying on business or there is other reason for it to continue in existence;
  - the "Societe Commerciale" is a party to legal proceedings;
  - the "Societe Commerciale" is in the process of being dissolved
  - there is an undischarged claim against the "Society Commerciale";
  - there exists a right of action to be pursued on behalf of the "Societe Commerciale";
- or
- for any other reason, it would not be just and equitable to remove the "Societe Commerciale" from the register.
4. When an objection is received on any ground specified above, the Registrar shall not remove the "Societe Commerciale" unless:
- the objection is withdrawn;
  - any facts on which the objection is based are not, or are no longer correct; or
  - the objection is frivolous or vexatious.
5. A "Societe Commerciale" will be removed from the register when a notice is signed by the Registrar that the "Societe Commerciale" is removed from the register and posted on the following website: <http://companies.govmu.org>
